We celebrated the 116<sup>th</sup> birthday of George C. Evans at our meeting on February 1<sup>st</sup>. Happy Birthday, George! As most of you know, George was a longtime member of Post 103. During the first World War, George served as a Navy seaman on the USS New Hampshire, a battleship that protected American warships from German submarines as they crossed the Atlantic. After the war, he lived to over the age of 100, becoming one of the oldest survivors of WWI. Upon his death, Post 103 adopted his name to honor him. Sometimes when I’m working at our weekly Bingo fundraiser, just like George did, I think about how we’re carrying on his legacy. I think he would be proud of Post 103.

Also at our February meeting, we commemorated Four Chaplains Day. Mike Romero led the service, with the help of John Mullin, Jack Pansini, Nick Arceo and Harry Giglio who read the parts of the chaplains. Thanks to all of them for this moving and meaningful service. Our next meeting will be on the evening of March 1<sup>st</sup> at the Buck Center. The Executive Board will meet on February 27<sup>th</sup>.

**Finance Officer - Ed Pietsch:** The Post is now operating under its new 2017 Budget which was approved at the December 7, 2016 meeting. Since our January meeting was snowed out, I have included summary information for December and January.

The winter months are usually slow for Finance purposes and the months of December and January were no different. In December, we had income totaling a little over \$1,000 comprised

of membership and All Veterans Honor Guard donations. In January, the total income was just over \$600 and included AVHG donations, membership and the Post Breakfast. Expenses in December and January pretty much matched the income. December expenses were just over \$1,000 including AVHG expenses, membership paid too Department, and office and operating supplies. January expenses were only \$400 and included dues to Department, AVHG, Post telephone and a few office expenses.

## **Veteran Service Officer- John Mullen:**

During the month of January, Post 103 assisted veterans in need.

Two veterans were helped with utilities, using \$437.00 from the VA Veterans Assistance Grant.

One veteran was helped with rent, using \$500 of Grant funds.

To date this fiscal year, we have spent the following:

Veterans Assistance Grant - \$15,700.63

Post 103 Veterans and Family Assistance - \$7,277.67

**JAG – Joel Mendelson:** No Report.

**Ed Pietsch – Bingo Manager:** The Post finished 2016 with a new record for income for the year but just barely beating out our 2015 numbers. We had a good Must Go in December and ended with just enough to give us a new record. January was not so good. We were snowed out our first session, and on the next we had both Progressive Jackpots (Bingo & Pull-tab) won by customers. The loss of the Progressive Bingo Jackpot virtually eliminated our chance of holding four, Must Go's during the year and that will cost at least \$6,000 in potential profit for 2017. We ended January with about \$1200 in profits for the month.

In December, Bingo paid out approximately \$1,000 in Post expenses including Storage Unit costs, contributions to Boys Scout Troop 114, and a donation to Toys for Tots. In January Bingo paid out about \$300 for the Post Breakfast, and two minor expenses for annual Post corporation fee to the Secretary of State and for Boys State.
